## **OMH Suicide Attempts - Data dictionary**

## Introduction

This dataset contains records of suicide attempts in DOCCS custody from January 1, 2014 to July 31, 2024 as reported by OMH. Note that the number of suicide attempts in this dataset may differ significantly from other data sources such as DOCCS' unusual incident data due to different reporting methods. Some facilities are split by unit and reported separately on different rows, reflecting the structure of the source data. To sum by facility, you can aggregate based on "FACILITY\_NAME". Please see the context statement above the dashboard for more detailed information.

The source data was obtained from OMH through the Freedom of Information Act Law (FOIL).

The data table is shared as a CSV file, with a bar ("|") delimiter in place of a comma (",").
